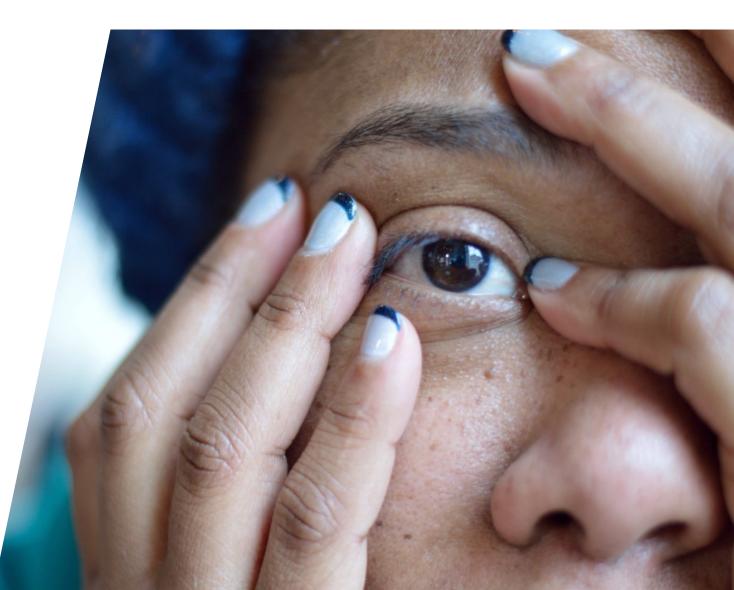

Objectives

Cultural Humility

- Commitment and active engagement in a lifelong process that individuals enter into on an ongoing basis with others (patients, communities, colleagues) and with oneself
- Allows for the fluidity and subjectivity of culture
- Challenges individuals and institutions to address inequities

Surface & Deep Culture

- Endpoint
- Knowledge of "other"

 Increased individual knowledge and awareness

Lifelong

- Intersecting layers of identity; understanding of others and ourselves
- Individual and organizational action and responsibility

3 Dimensions of Cultural Humility



Lifelong learning and critical self-reflection



Recognizing and redressing power imbalances



Institutional accountability

Support African American cancer caregivers by engaging in lifelong learning and critical selfreflection



Support African American cancer caregivers by holding institutions accountable



Individual-Level Questions

...for critical self reflection

- How do my cultural identities shape my worldview in relation to African American caregivers?
- How much do I value input from African American caregivers?

...to address power imbalances

- What experiences are African Americans caregivers having that are related to oppression and larger systemic issues?
- How do my own behaviors actively challenge power imbalances African American caregivers may experience?

Institutional-Level Questions

...for critical self reflection

- How can our organization's culture better encourage respectful, substantive discussions about improving the support we provide to African American caregivers?
- Do our processes allow us to apply lessons learned about providing more effective caregiver support?

...to address power imbalances

- How do we engage with the African American community to ensure African American voices are embedded our work?
- What organizational structures do we have that support action to monitor and improve health equity in cancer care?

Patient Hx

- 64 y/o female-widow
- Adult son is her caregiver
- 2011 diagnosed with granulosa cell tumor of the ovary in Nigeria
- 2019 moved to the U.S. near her son
- Cancer recurrences: 2019 & 2020

Key Elements

- Did not tolerate cancer treatments well
- Mistrust of previously local physician in Nigeria
- Financial assistance needed once arrived in the U.S.
- Son struggling to work while providing care to his mother

Barriers/Challenges

- Lost trust with Nigerian physicians and felt that she was not heard or listened to therefore brought to the U.S. and cared for by her son.
- Embarrassment due to lack of finances to cover tx.
- No available financial assistance or proper direction of who to contact.
- Son struggling to help his mother while trying to continue working.
- Could not tolerate chemotherapy treatments.




Develop a tangible resource that integrates knowledge learned from the ECHO
